# Writing Principal for International Conference on E-learning and Educational Technology 2018 

The writing examples are referred to the <Publication Manual of the American Psychological Association ${ }^{\circledR}$, Fifth Edition>. The brief relevant principals of texts, citations, references, tables and figures as follows:

I Text
I. 1 Please check accuracy of grammar and the fluency of sentences in both abstract and main-text of your manuscript before submitting.
I. 2 The title of the text should be numbered in order. For example, I. Introduction, II. Methods, III. Results, IV. Discussion, and V. Conclusions.
I. 3 The title of the text should be numbered in order by different structure levels. For example, I, A, 1, a, (1), (a).
I. 4 Names are showed as original or unchanged, and use initial only at the first time they appear in the text. For example, show the name with initial at the first time in the text, "J. Dewey", and show the last name afterwards in the text, "Dewey".
I. 5 The appendix should be placed after the References.
I. 6 The minimum pages and the maximum pages of the poster presentation manuscript are 2 pages and 4 pages; the oral presentation manuscript pages are less than 8 pages; English font should be Times New Roman. For the other writing principles of main-text, please refer to the Manuscript Main-text Writing Style Guidelines.
II Citation
II. 1 The citation information must be consistent with the references information.
II. 2 Please list all the author names in the first citation in case of the number of authors for the citation is three to five. For example, Si-Hua Huang, Yuan-Zhen Liu and Wan-Ting Yan (2011). Only list the first author's name from the second citation. For example, Si-Hua Hunag (2011).
II. 3 Only list the first author in the case of the number of the authors is more than six, no matter which time it is, for example, Robbins et al. (1960); Wu-Dian Wu et al. (1972).
II. 4 Please use a comma to separate the different years in case of the citations with one author. For example, Yuan-Zhen Liu (2007, 2008).
II. 5 The foreign author names in citation references are listed before the English ones. For example, (Asunción, 2003; James, 2007).
II. 6 Please use symbol of " / " to separate the publication year of the original edition and translation edition. For example, (Beck, 1991/2001).
II. 7 Please state clearly the page number of the citing references to extract the
specific paragraph in an article or quote the words of someone. If the citation covers more than forty words, then you are able to show them in another paragraph and indent three words of space for each line.
II. 8 Use Half-width Form punctuation marks for each citation.
II. 9 Please refer to <Publication Manual of the American Psychological Association ${ }^{\circledR}$, Fifth Edition> for further detailed citation principals.
III Reference
III. 1 The references must be listed alphabetically.
III. 2 If the reference is from United States of America, then you show the abbreviation of the sourced state, or only show the big metro-city in USA such as New York and Chicago without the abbreviation of the state that the reference source from.
III. 3 Please show the names of the country and the city in case of the references from the country other than USA. If the city is famous in the world, then only show the name of the city, for example, Paris.
III. 4 The title of books and journals or the number of the volume \& issue should be in italics.
III. 5 Please refer to <Publication Manual of the American Psychological Association ${ }^{\circledR}$, Fifth Edition> for further detailed citation principals.

## IV Figure \& Table

IV. 1 Show the title above the table, and show the description and source respectively under the table.
IV. 2 Show the title above the figure, and show the caption and source respectively under the figure.
IV. 3 It is allowed not to indicate the sources of the figures and tables made on your own.
IV. 4 Please make afresh the figures and tables if they are too indistinct to read after scanning.
